General

- 18. In the event of any inconsistency between these Terms and Conditions and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, these Terms and Conditions shall prevail.
- 19. These Terms and Conditions shall be governed by the laws of Malaysia and all Customers are deemed to have agreed to submit to the exclusive jurisdiction of the Malaysia Courts.
