



**FREQUENT ASKED QUESTIONS (FAQs)
SPEED LIMITER DEVICE (SLD) FOR COMMERCIAL VEHICLE**

1. What is a Speed Limiter Device (SLD)?

A Speed Limiter Device (SLD) is a speed control device or system designed to limit a vehicle's maximum speed. For commercial vehicles in Malaysia, the limit is set at 90 km/h.

2. Why is the Speed Limiter Device (SLD) mandatory now?

The Ministry of Transport (MOT) is enforcing the use of Speed Limiter Device (SLD) on commercial vehicles to improve road safety, reduce accidents, and ensure safer driving practices among heavy vehicles.

3. Which vehicles are affected?

The regulation applies to:

- All tour buses, express buses, and heavy goods vehicles, maximum weight exceeding 3,500 kg (Gross Vehicle Weight, GVM > 3,500 kg).
- Passenger vehicles above GVW 5,000 kg or carrying more than 8 passengers.

4. When will this rule be enforced?

The regulation will be rolled out in three phases:

- Phase 1 (1 Oct 2025): Verification of SLD function for vehicles manufactured **after 1st January, 2015**
- Phase 2 (1 Jan 2026): Activation of SLD for vehicles manufactured **before 1st January, 2015**, and equipped with an SLD function.
- Phase 3 (1 Jul 2026): Mandatory retrofit installation for vehicles without SLD

5. How to check my vehicle is categorized under which phase?

- You may visit or contact your nearby Authorized Hino 3S Service Centre to check the categorization.

6. How do I know if my Truck is already equipped with Speed Limiter Device?

- The easiest way is if you notice your current vehicle speed cannot go more than 100km/h or 90km/h.
- To be more precise, you may refer to the Affected Models as item 5 or refer to our HINO 3S Dealers.

7. My Hino truck is already equipped with a Speed Limiter Device. Do I need to do anything?

- If your vehicle already has an SLD installed, from 1st September 2025 onwards, you may visit our Authorized Hino SLD Verification Centres (Authorized Hino 3S Service Centre) to arrange speed adjustment for your vehicles.
- Please make appointment with Authorized Hino 3S Service Centre, one to two weeks before Routine Inspection (*Pemeriksaan Berkala*) at PUSPAKOM.

8. What if my truck does not have a Speed Limiter Device?

- Vehicles without SLD must install an approved retrofit device by 1 July 2026.
- Currently, Hino Malaysia do not have our own Hino authorized retrofit to offer customer. Customers may install the SLD at any JPJ approved technical support or service workshop centre.

9. What is the cost for the Speed Limiter Device adjustment or installation?

Please contact Authorized Hino SLD Verification Centre (Authorized Hino 3S Service Centre) for the charges.

10. How much time is needed to complete the adjustment?

The complete adjustment is estimated to take between 60 to 90 minutes, including checking, adjusting and documentation process.

11. After the Authorized Hino SLD Verification Centre performed the checking and speed adjustment, which documents will be provided by the Hino dealers?

The documents provided as below:

- SLD Functionality Confirmation Slip (*Slip Pengesahan Kefungsian SLD*)
- Attachment: Report of Diagnostic Tool (DX-III Report)

12. What should I do with the documents mentioned in no.11. (SLD Functionality Confirmation Slip and Report of Diagnostic Tool)?

- These documents are required for permit applications and PUSPAKOM Initial Inspections (*Pemeriksaan Awalan*).
- In addition, one copy should always be kept inside your vehicle.

Yes, all new units are equipped with a speed limiter device (SLD) set at 90 km/h.

15. Do the new vehicles come with a SLD Functionality Confirmation Slip?

Yes, all new vehicles are provided with the SLD Functionality Confirmation Slip.
